The United Nations (UN) has made the reduction of extreme poverty and hunger the first agenda in the Millennium Development Agenda. This is because poverty degrades and lowers humanity. According to African Union (2006), poverty is pain; it seems like a disease, it attacks a person not only materially, but also morally, it eats away human dignity and leads to complete despair. Therefore, even before setting the Millennium Development Goals for 2015 and setting the 20:20-20 vision for 2020, Nigeria has vigorously tried to prevent extreme poverty from its civic organizations. Government of Borno State has been working around the clock to reduce this menace through its federal government programs, creation of enabling environment, creation of local programs and plans and establishment of Ministry of Poverty Alleviation.

2. Literature Review

The study revealed that a lack of effective governance structures, coupled with widespread corruption and impunity, undermine institutional capacity, trust in authorities, and overall peace-building efforts.
- vi. Internally Displaced Persons (IDPs) and Refugees: The presence of a significant number of internally displaced persons and refugees in the north east region poses an additional challenge to sustainable peace. The study highlighted the strain on resources, social cohesion, and access to basic services caused by the ongoing displacement crisis.

These findings demonstrate the complex and interconnected nature of the challenges facing sustainable peace and conflict mitigation in the north east region of Nigeria. Addressing these issues requires a multi-dimensional approach, involving effective governance, socioeconomic development, conflict resolution mechanisms, and security reforms.
